Hazel is survived by her mother Florence Allen; brothers, Ed Allen and Roy Allen (Cathy), several nieces and nephews all of Billings, MT; her forestry family with California License Forestry Association; Charlene Davis and the Hilton staff at Arden West; and her long-time friend Jose Cena.

The following agenda for the November meeting in Sacramento which was held on November 5-6 for topics covered. October was a dark month for the Board of Forestry and Fire Protection. The December meeting will be held on December 10-11, 2019 in Sacramento and the agenda can also be found at the link above.

The following is a list for items of greatest interest to the RPF community from the November Board of Forestry Meeting:

FULL BOARD MEETING

- The Board has passed the threshold for new rulemaking to be effective by January 1, 2020, so the following items will be effective Jan 1, 2021 if they are adopted.
- All of the following regulatory action items from the agenda were moved forward unanimously to the phase noted: "Fire Safety Survey, 2019" 15 day notice; "Subdivision Map Findings, 2019" 15 day notice; "Very High Fire Hazard Severity Zone Adoption, 2019" 15 day notice; "Registered Professional Forester and Certified Specialty Amendments, 2019" 15-day Notice with minor modifications, "Southern Subdistrict and Marin Co. Point Count Amendments" 45 day notice, with support from County of Marin; "Categorical Exemption Amendments, 2019" approval of Initial Statement of Reasons; "Appeal Amendments, 2020", 45 day notice.

MANAGEMENT COMMITTEE MEETING

- A joint committee meeting was held amongst all three board committees (Management, Forest Practice, and Protection).
- No action was taken on Management Committee items during this meeting, and there are not scheduled for the December meeting.
- CAL FIRE Annual Exemption Monitoring Report to the Legislature the draft report will be available for public review shortly. Another update will be given to the Board at the December meeting.
- Steep-Slope Harvesting
 - The Board desires to consider regulatory action to clarify limitations on the use of ground-based equipment in cable and tractor yarding areas pursuant to 914.2 Tractor Operations and 914.3 Cable Yarding in order to address current logging technology and techniques including steep-slope tethered logging, tethered falling and bunching under cable systems, and shovel logging.
 - This item will be developed over the next few months and may result in a rule package to be included in the 2021 Forest Practice Rules.
 - The Full Board received presentations from Miller Timber Services and Campbell Global on the use of tethered systems occurring in California to date.
 - Emergency Notice for Fuel Hazard Reduction 14 CCR 1052.4

The Board engaged in Emergency Rulemaking to expeditiously pass amendments to 1052.4 earlier this summer. The emergency rules for the Emergency Notice for Fuel Hazard Reduction are currently in effect until February 11, 2020. This is a great opportunity – use it!! The Board may extend these regulations for an additional 180 days. The Board worked to address issues that were tabled during the previous rulemaking effort in order to engage in regular rulemaking to make permanent revisions to this rule section. It is expected that a final plead may be available for review at the December meeting.

Agenda Item of Note:

CONSENT ITEMS 3. Foothill yellow-legged frog. The FGC received the Department's one-year status review report on the petition to list foothill yellow-legged frog (Rana boylii) as an endangered or threatened species under the California Endangered Species Act.

Findings: (See Figure 6 of the report below for DFWs clade recommendations.) In addition to evaluating the petitioned action to list the species as threatened or endangered, DFW evaluated whether listing the species was warranted for six unique genetic clades (a clade being a group of organisms that consist of a common ancestor and all its lineal descendants). The status review contains DFW's recommendation that listing the foothill yellow-legged frog is warranted at this time for five of the six genetic clades, with three specific recommendations: List the Feather River and Northeast/Northern Sierra clades as threatened;

List the East/Southern Sierra, West/Central Coast, and Southwest/South Coast clades as endangered;

Do not list the Northernwest/North Coast clade; listing is **not warranted** at this time.


Tentative Expected Timeline for Action and Implementation

The FGC received DFW's status review of the Foothill yellow-legged frog at the October meeting. The FCG may vote at the December 11-12 meeting to determine if the proposed listing is warranted. If they vote, findings will be adopted at a later future meeting.

(Pursuant to Section 2073.5, Fish and Game Code) The Department will recommend that this item be continued to a future meeting.
