## President's Message

There are not enough foresters! There is a cry for our expertise. Positions remain vacant. Just look at the employment announcements on CLFA's web site. We turn landowners down for moonlighting work all the time, even when they offer to pay for nothing more than advice. I had a college professor that told the class on the first day, "There are no jobs in forestry." How wrong they were. Many people are concerned about the future of forests right now and don't know what to do about it so they are turning to us for answers.

I found forestry by accident during my college career. I didn't know there was a profession of forestry. I was thinking of a wildland firefighting career and was advised to get a forestry degree so I could move up in rank later in my career. I took Intro to Forestry and soon thereafter, quit the volunteer fire department and took an intern position in forestry. I was hooked. I'm not comparing firefighting with forestry. One just suited me better than the other.

The idea that young people today don't want to do this kind of work, I think, is incorrect. It has always been something that suits certain people. We try to recruit but usually in vain. I implore you; don't give up! We are searching for needles in haystacks so we need check every haystack. They are out there, those young people that would do what we did and find a job they love to the point that the job becomes part of their identity.

The pendulum is swinging. Many people are burned out on office work. They want a balance of outdoor and indoor life. That's exactly what forestry offers. We use high tech tools, communicate with important people, and still get to see and experience landscapes that few others do. All of that while on-the-clock getting paid. Forestry is cool right now. Look at Justin Timberlake's current concert tour called the "Man of the Woods 2018 Tour". He is probably tired of being a famous singer and would love to be a forester but the schooling and apprenticeship are too daunting. Seriously, we should take advantage of any cultural tide in our favor.

Let's keep recruiting. At the moment, we're increasing our outreach effort to high school students, Future Farmers of America, California Conservation Corps, and job fairs. It's a tough row to hoe but worth the effort.

## FOREST PRACTICE COMMITTEE

Forest Practice Program Plan Submissions (through 03/31/2018):

- ◆ THP Submissions: The number of THP submissions through March 2018 was ten (10) more than through March 2017 (52 compared to 42 in 2017). •
- ◆ NTMP Submissions: The total number of NTMP submissions for March 2018 was double that of March 2017 (6 compared to 3 in 2017). Zero (0) NTOs were submitted in March 2018 compared to seven (7) for March 2017. • Exemption Notice Submissions: Exemption submissions were approximately 6% higher compared to March last year (465 compared to 435 in 2017). The number of Drought Mortality Exemptions filed through March 2018 is approximately 34% lower than last year (65 compared to 98 in 2017); the acreage covered was approximately 67% lower (2,270 acres compared to 6,942 acres in 2017). • Emergency Notice Submissions: Emergency Notice submissions were approximately 85% higher in March 2018 than March 2017 (58 compared to 10 in 2017). •
- ◆ Plan Approval: 82 THPs were approved in March 2018 compared to 56 in March 2017. The same number of NTMPs (2) were approved in March 2018 as were approved in March 2017. Timber Regulation and Forest Restoration Fund (TRFRF) Activities [Updated from the TRFRF Database (01/01/2018 through 02/28/2018)] •
- ◆ Since January 1, 2018, the Department has expended 39,709 hours in conducting Forest Practice Program activities funded by TRFRF. An additional 2,882 hours of Forest Practice Program activities not funded by TRFRF has also been completed. Combined, Department staff has recorded 42,591 hours of Forest Practice-related activities through March 31, 2018. 2 Timber Operators Licensing (LTO) and Forest Practice Enforcement Updates • Enrollment for the fall timber operator classes opens on May 1st . •
- ◆ Starting May 1st, Forester II, Thembi Borrás will begin her assignment as the Northern Region Forest Practice Enforcement Specialist.

## Legislation

### Jason Wells—Committee Chair

May 25<sup>th</sup> was the last day for bills to move out of their respective appropriations committees for the floor. If bills did not make it out of committee by that day, they are now dead. Bills which the CLFA SUPPORTED which are now dead include:

- ◆ AB2208 (Aguiar-Curry) – Biomass RPD Procurement Mandate
- ◆ AB2842 (Bigelow) – Wood Products Grant Program
- ◆ AB2585 (Patterson) – Rx Fire Liability Protection for use of Burn Managers
- ◆ AB2645 (Patterson) Greenhouse Gas Reduction Funds for Forest Management
- ◆ AB2120 (Quirk) Wildfires – Greenhouse Gas Emissions Annual Report
- ◆ AB2672(Patterson) – Greenhouse Gas Study of Wildfire Emissions

Bills which are dead in which the CLFA OPPOSED are :

- ◆ SB1414 (Beall) – THPs regarding San Jose Water Company.

Unfortunately, there are a number of live bills which are politically expedient, but lack thoughtful consideration of potential adverse effects, which oppose the current federal administration. SB49 (DeLeon), AB2627 (Kalra) and SB 473 (Hertzberg) are all, so called, “Trump bills” which aim to increase state mandated protections in advance of possible reductions of environmental protections at the federal level.

### WATER QUALITY

The Board met on May 17<sup>th</sup> in Santa Rosa. No forestry topics were presented in the open session. The board met in closed session to consider evidence received in closed session to discuss initiated litigation in the following matters (Gov. Code, § 11126, subd.(e)): Petitions of: Jesse Noell, Stephanie Bennett, Kristi Wrigley and Elk River Residents Association; Pacific Coast Federation of Fisherman's Association; and Environmental Protection Information Center and North Group of the Redwood Chapter Sierra Club for Review and Stay of Order No. R1-2016-0004, Waste Discharge Requirements for Nonpoint Source Discharges and Other Controllable Water Quality Factors Related to Timber Harvesting and Associated Activities Conducted by Humboldt Redwood Company, LLC in the Upper Elk River Watershed, Humboldt County (December 30, 2016).

The next Board meeting will be Thursday July 11<sup>th</sup>, 2018 in Santa Rosa. No specific forestry items are on the agenda. The *Elk River Pilot Project* CEQA Certification is an action item on the draft agenda and may be worth following if interested or affected by Elk River policy or TMDL. The *Pilot Projects* are described in the TMDL for Elk River as a means to remediate sediment and recalculate the TMDL load allocations.

### WILDLIFE

**The Fish and Game Commission:** <http://www.fgc.ca.gov/meetings/2017/index.aspx>. The Commission last met April 18<sup>th</sup>-19<sup>th</sup> in Ventura.

The Commission considered the petition, Department's evaluation report, and comments received to determine whether listing the Lassics lupine (*Lupinus constancei*) as a threatened or endangered species under CESA is warranted (Pursuant to Sections 2075 and 2075.5, Fish and Game Code). Two occurrences of Lassics lupine are known from USFS, Six Rivers National Forest lands in Humboldt and Trinity Counties; this species is associated with ultramafic soils (serpentine barrens). Findings will be adopted at a future meeting.

EXECUTIVE SESSION (Not Open to Public) Pursuant to the authority of Government Code Section 11126(a) (1), (c)(3), and (e)(1), and Section 309 of the Fish and Game Code, the Commission met in closed Executive Session. The purpose of this Executive Session was to consider pending litigation to which the Commission is a Party. The following forestry-related topics were considered:

- ◆ California Fish and Game Commission v. Central Coast Forest Assoc. and Big Creek Lumber Company (Coho delisting south of San Francisco)
- ◆ California Cattlemen's Association and California Farm Bureau Federation v. California Fish and Game Commission (gray wolf listing)

The next meeting will be held June 20<sup>th</sup> – 21<sup>st</sup> in Sacramento. The agenda is not yet available.





## HAROLD H. BISWELL MEMORIAL SCHOLARSHIP Pioneer of Fire Ecology

### 2018/2019 SCHOLARSHIP APPLICATION & INSTRUCTIONS



The California Licensed Foresters Association (CLFA) is pleased to announce that we are currently accepting and facilitating scholarship applications for the **2018/2019 Harold H. Biswell Memorial Scholarship**. The scholarship is available to students pursuing an education in Forestry and who will be attending, full time during the 2018/2019 school year, a University or College with a Forestry Program accredited by the Society of American Foresters (SAF) **OR** a Junior College with transferable credits to an accredited Forestry Program. The application must be sponsored by a voting member of CLFA, a Professor of a University or College with a Forestry Program accredited by the Society of American Foresters (SAF) or a Junior College with transferable credits to an accredited Forestry Program. The student must be entry level, either a recent high school graduate, or student who will be attending their first year of a college program in the 2018/2019 school year.

The successful applicant will be awarded a \$1000 scholarship and a complimentary admission to the CLFA Annual Conference, to be held in March-2019, in Anderson, CA. To receive payment the successful applicant will be required to submit an enrollment verification form to CLFA during the Fall Semester of 2018.

This scholarship has been named the Harold H. Biswell Memorial Scholarship in honor of Professor Harold H. Biswell, pioneer fire ecologist. To represent all that Harold stood for to all those who were touched by this great man is a humbling experience. The profession of fire management underwent a paradigm shift in the 1960's, and the man who, more than any other, actually shifted the focus of the fire culture was Harold Biswell. Professor Biswell pioneered much of his fire ecology work while at the University of California, Berkeley. The idea of underburning forests to prevent more destructive wildfires was a revolutionary idea in California at the time, although fire was routinely used in some shrublands. Despite Dr. Biswell's contributions to our profession, he was widely criticized for the same ideas, presented in the same way, for which he received so much favorable response later in his career. Because some of his monikers, like "Harry the Torch" or "Dr. Burnwell," were acquired during the early days of controversy he nevertheless pursued his passion despite the odds against him.

# Update on California's 2030 Natural and Working Lands Climate Change Implementation Plan

**BACKGROUND:** The [2017 Climate Change Scoping Plan Update](#) commits the State to finalizing a goal for carbon sequestration and greenhouse gas (GHG) emission reductions on natural and working lands by September 2018. The 2030 Natural and Working Lands Climate Change Implementation Plan (NWL Plan) will further describe this GHG goal and provide a blueprint to achieve it through state-funded conservation, restoration, and management activities.

The NWL Plan will detail regional targets for a variety of state-funded conservation, restoration, and management practices that sequester carbon, such as wetland and meadow restoration, fuel reduction and improved management in forests, soil conservation on rangelands, and avoiding land use conversion from development. These acreage targets will be run through California-developed carbon models to project cumulative GHG benefits of these activities by 2030, by region and statewide.

**PURPOSE:** Regional meetings are intended to help state agencies gain feedback on opportunities and priorities and refine draft acreage targets for conservation, management, and restoration practices to be modeled and included in the final NWL Plan. These workshops seek engagement with landowners and stakeholders from Resource Conservation Districts, land trusts, nonprofits, academic institutions, NGOs, and local, regional, federal, and tribal governments, with the goals of:

1. Ensuring that draft regional acreage targets for resource management are inclusive of significant local plans, goals, and programs, particularly regional multi-partner or landscape-scale plans; and
2. Better understanding local priorities and stakeholder needs for successful regional implementation of the NWL Plan through 2030.

**We ask that you please bring information on existing plans for conservation, restoration, and management priorities and targets as described above to inform our discussion. After the workshop, we will continue to solicit this information before regional targets are finalized for the NWL Plan.**
