# **Presidents Message**

There's something to be said about the impact that those who have come before us have had on our lives, both professionally and personally. Most of us have at least one colleague they consider a mentor, an inspiration, or at least an example by which they want to emulate in order to be successful in their lives. Myself, I have an ever-growing list of colleagues that I deeply respect on both personal and professional levels from whom I have learned and grown by their association. Employers supported CLFA's mission and encouraged my participation and professional development. I think it's hard to recognize in the moment the impact that you have on those around you.

I'd have a hard time chronicling the more subtle impacts that colleagues have had on me, but I've learned quite a lot from many of you who may be reading this and my attempts to garner your respect (or at least not completely lose it) have driven me to become a better forester. A forester I worked under was insistent that I know the answer to every guestion he could ask me about plans I worked on. If a watercourse was Class II he wanted to know where exactly it broke into a Class III, regardless of my experience making such a call, it was my responsibility to be able to justify my decision and be confident in my conviction. This attitude really began my post-university study on forest management, and my continuing education has no end. It wasn't until much later that another respected colleague told me that I didn't need to know the answer to every question, but I should promise to try and find out. This doesn't work on a PHI, but it's an essential piece of advice for most professional scenarios.

I've tried, and continue to try, to pay forward the generosity and display the professionalism that others have granted me. It's important that those who follow in our footsteps find that our examples provide a pathway that they can envision leading to success.

# Andrea Eggleton—Regulatory Rep to CLFA

The Board of Forestry and Fire Protection was dark in February and is meeting on March 1-2, 2022 via webinar. The Management Committee held a workshop on Less Than Three Acre Conversion Exemptions on February 7, 2022.

The workshop considered the letters received from a <u>Building Coalition</u>, <u>Nevada County</u>, and <u>RPF Dean Loftus</u>, which all raised issues surrounding this type of exemption.

- No decisions were made about specific revisions to rule language. The committee adjorned with
  direction to the Board Staff to consider which of the concerns raised that the Committee would like
  to work to mitigate and to look within the statutory requirements to see what kinds of revisions are
  possible.
- This issue will be substantively covered at the March BOF meeting.
- The Board is considering such issues as removing the 30 feet surrounding approved and legally permitted structures from the definition of Timberland in observance of the PRC 4291 requirements for defensible space, as suggested by Dean Loftus. The Board is also considering extending the time frame of viability to 5 years for timber operations and 2 years for conversion activities, with a potential 2 year extension.

February 18th marked the deadline for legislators to introduce new bills. Many of these bills are "spot bills" at this point, meaning they at best have a title that reflects what their intent is (which isn't always what they end up being about). Authors have 30 days to amend these bills, so we should be finding out more information about what is coming up this legislative season in the near future.

### California Fish and Game Commission

The Commission last met on February 16<sup>th</sup> via teleconference.

- The Commissions continued the decision to determine listing of the Southern California steel-head as Endangered under the California Endangered Species Act.
- The Commission continued the decision to ratify the Northern California summer steelhead as endangered under the California Endangered Species Act.
- The Commission received a petition from the Humane Society of America to eliminate open hunting season for black bear until CDFW updates the Bear Management Plan to include a population census. The petition was referred to CDFW. Agenda & Summary.

### California Department of Fish and Wildlife

CDFW Awards \$13 Million For Coho Recovery Projects on The North Coast
Pilot Project to Return Salmon to Their Historical Habitat Above Shasta Dam Receives Initial Funding

### **US Fish and Wildlife Service**

- The Service conducted a 90-Day finding for the Variable Cuckoo Bumblebee (*Bombus variabilis*) and determined the petition contained substantial information indicating listing may be warranted under the Endangered Species Act. California is listed as being part of Variable Cuckoo Bumblebees range. Proposed Rule.
- The Gray Wolf (Canis Lupus) is yet again protected under the Endangered Species Act in 44 states, including California, after a ruling by the US District Court for the Northern District of California issued on February 8, 2022. Article.
